Footnote 1: Any person employed in the class of Safety Engineering Associate (Class Code 1726), for which registration as a professional engineer with the California State Board of Registration for Civil and Professional Engineers is not required, shall, while so registered, receive salary at the second premium level rate (5.575625 percent) above the appropriate step rate of salary prescribed for his/her class, at the beginning of the payroll period next succeeding the date the individual presents to the Department a formal certificate or pocket identification card or other such document or communication evidencing registration as a professional engineer satisfactory to the Department.

Footnote 2: One person in the class and level of Utility Accountant D (Class Code 1511), DDR No. 23-15122, who was formerly assigned to DDR 82-15103 or DDR 94-15119 will be compensated at the level of Utility Accountant C.

Footnote 3: Any employee in the class of Utility Accountant (Class Code 1511) or Senior Utility Accountant (Class Code 1521) who maintains registration as a Certified Public Accountant (CPA) or Certified Internal Auditor (CIA) shall be reimbursed by the Department for the cost of such registration upon presentation by the employee of a paid receipt for such cost.

Footnote 4: Any employee occupying a position in the class of Utility Accountant (Class Code 1511) or Senior Utility Accountant (Class Code 1521), who has been granted the authority by the State of California to use the term of Certified Public Accountant, shall be compensated at the second (2nd) premium level above the rate established for the position.

Footnote 5: Any employee who is appointed from a Civil Service eligible list to the class of Management Aide, Code 1508, whose hourly compensation immediately prior to such appointment is higher than the 5th step hourly rate for Management Aide, shall continue to receive compensation at the same hourly rate that the employee was receiving on the date prior to such appointment. The employee shall continue to receive the hourly rate assigned upon

appointment to Management Aide until such time as the prescribed hourly rate for the class of Management Aide exceeds the salary assigned to the employee or the employee receives an appointment to a class and pay grade with an hourly rate higher than the hourly rate assigned upon appointment to Management Aide.

Persons employed in the class of Management Aide on October 1, 2001, who were appointed from a Civil Service eligible list to that class, whose hourly rate of compensation immediately prior to October 1, 2001, was higher than the 5th step hourly rate for Management Aide, shall continue to receive such hourly rate of compensation until such time as the prescribed hourly rate for the class of Management Aide exceeds the salary assigned to the employee or the employee receives an appointment to a class and pay grade with an hourly rate higher than the hourly rate assigned under the provisions of this Salary Footnote.

Footnote 6: Employees occupying DDR No. 93-17109, in the class of Utility Management Assistant (Class Code 9100), as of October 1, 1996, shall be paid at the fourth (4th) premium level above the appropriate step rate in the salary range while occupying this DDR. Any employee assigned to this DDR subsequent to October 1, 1996, shall be paid in accordance with the salary range established for the Management Analyst II (Class Code 9169) level.

Footnote 7: Effective December 1, 2001, new employees assigned to positions in the classes listed below will only be able to occupy the DDR listed opposite the class title.

Footnote 9: An employee who is appointed from a Civil Service eligible list to the class of Systems Aide, Code 1599, whose hourly compensation immediately prior to such appointment is higher than the 5th step hourly rate for Systems Aide, shall continue to receive compensation at the same hourly rate that the employee was receiving on the date prior to such appointment. The employee shall continue to receive the hourly rate assigned upon appointment to Systems Aide until such time as the prescribed hourly rate for the class of Systems Aide exceeds the salary assigned to the employee or the employee receives an appointment to a class and pay grade with an hourly rate higher than the hourly rate assigned upon appointment to Systems Aide..
